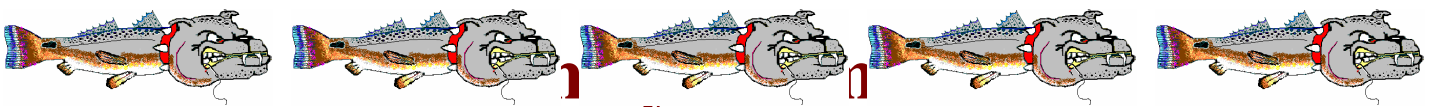
Rules and Regulations

- 1) State of Texas game fishing laws, regulations, and possession limits will apply to all entrants.
- 2) Winners to be determined by weight. The tournament scale used at the weigh-in is the official scale. In case of a tie in weight, the first to weigh-in wins.
- 3) An oversized redfish may be weighed as part of your **3** redfish stringer, but must be properly tagged at time of weigh-in. Improperly tagged or untagged oversized reds will be disqualified.
- 4) Entrants can win in only one category. Winners will be determined by highest placing in any eligible category.
- 5) Fish must be caught by rod and reel only.
- 6) No sharing of catches allowed. Each fish will be measured and marked at weigh-in. Illegal fish will be disqualified.
- 7) Fish may be iced down. No gutted, gilled, or mutilated fish will be weighed in. Cloudy eyes or pink gilled fish will not be accepted. Tournament reserves right to inspect any suspicious catch inside or out.
- 8) Tournament is open to all employees (both current and retired), employee's spouses, siblings, parents, and tournament sponsors. Non-employee's and immediate family's guests will be allowed, but they **MUST** fish with an employee (current or retired), employee's spouse, employee's sibling, employee's parent, or tournament sponsor. No professional guides or commercial fishermen allowed.
- 9) All boat occupants must be entered in the tournament.
- 10) All entrants **MUST** sign the liability waiver on the entry form to be eligible to fish.
- 11) Tournament scale to be used for official weigh-in **ONLY**. Each fisherman must have his/her individual catch ready for weigh-in. Tournament scale will not be used to cull fish.
- 14) Tournament will immediately penalize, up to disqualification; any participants suspected of breaking tournament rules.
- 15) In case of inclement weather, tournament will be rescheduled. No refunds given on entries after **June 18th**.
- 16) Salty Dog highly recommends that every fisherman attend Friday night rules meeting to be aware of any discussions or changes, which may occur.
- 17) Weigh-in deadline-6:30pm at tournament headquarters.
